Thank you for visiting xeetimes.com. This privacy policy sets out our online information practices and the choices you can make about the information collected through our website. - o When we believe in good law, we must give your personal information to third parties;
- O Your personal information has been provided to other third parties, we have your prior authorization, which we will obtain at the time of collecting information from you.

How we use the personal information we collect:

- o To authorize and process credit card transactions that you enter online;
- o To help provide the products and services you requested;
- o To provide you with information about other websites, products and services that we consider may be in your interest;

We may use a cookie file that contains information that can identify the computer you are working on. The cookie file is anonymous because it only gives us details of your IP address, PC platform (Windows, Linux or OS X), browser (such as Internet Explorer, Google Chrome, or others, plus the version of the browser) and domain (whether you) Reaching the site from the Maldives or elsewhere). We may use the information generated by "cookies" to:

Explicit gifs are small graphics with a unique identifier, similar to the function of cookies. Explicit gifs about web users' online movements can ping or alert an advertiser's server. The main difference between cookies and explicit gifs is that explicit gifs

are invisible on the page and are very small. We do not have access to any information collected by these explicit gifs nor may additional information be tied to them by the advertiser.

Xeetimes contract with online measurement companies and other service providers to manage and optimize Internet business and communications. These companies collect information about visiting our site to analyze site performance and advertising effectiveness, and to help us optimize the site for readers and marketers.

Third Party Ad Servers

When you come to our website, some of our advertisers use third party companies to advertise.
